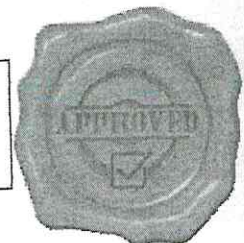

Conclusion


